- Mirror X Photo Booth; 3 hrs. @ \$650 additional time upon request (\$150 per additional hr.)
- Vintage trailer rental; 3 hrs. @ \$1200 additional time upon request (\$300 per additional hr.)

Schedule of Payments: 50% due at signing; 50% due 30 days prior to event date. Payments can be made online via our website [www.califotobooth.com](http://www.califotobooth.com)

1. This agreement constitutes an order for a Cali Foto Booth photobooth or trailer rental, including the taking of any photos as agreed to by both parties: The Studio (also known as Mirror X dba Cali Foto Booth) and Contracting Party (Client). This agreement contains the entire understanding between the Studio and the Client. It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing, signed by all parties.
2. Unless otherwise specified, it is understood that any and all rights to proofs, final or sample prints, thereof shall remain the property of Cali Foto Booth Inc. Cali Foto Booth Inc. gives an unrestricted license for use by client, in accordance to the law. Cali Foto Booth is not responsible for any unintended usage by client.
3. Cali Photo Booth requests that any editorial use of images taken in print are to be credited to "Cali Foto Booth, [www.Cali Foto Booth.com](http://www.CaliFotoBooth.com)." If published online, image credit must contain text: "Cali Foto Booth" with a hyperlink to <http://www.CaliFotoBooth.com>
4. We reserve the right to publish selected photos on social media, blog and website. (Please let us know if you'd like to approve any postings from your event; in general we will ask anyway).

5. Complimentary gallery provided by the Studio will always have the Cali Foto Booth logo in addition to the text. High resolution images will not have any logos or text.
6. On signing of this agreement by both parties hereto, The Studio will reserve the time agreed upon and for this reason the deposit is non-refundable even if the date is changed or if the event does not take place for any reason. The Studio will evaluate individual situations, and attempt to accommodate schedule changes on a case-by-case basis.
7. Operational hours are to be consecutive unless otherwise arranged. Idle time charges may apply for splitting our services. Operation time can be applied towards the idle time. Mirror X crew will arrive 1-1.5 hours prior to the event, and breakdown and load-out immediately after the end time. When making the timeline, keep in mind that idle time charges will apply if Mirror X is to load in prior to 2.5 hours of operation, or be requested to load out after 30 minutes after the end of operation. (Example of regular procedure: Load in 6pm, Operation start 8pm, 3 hours of operation, Breakdown and load out 11pm).
8. If the Studio is unable to perform to the guidelines of this contract due to a fire or other casualty, strike, catastrophic act of God (not including rain), act of terrorism, or other cause beyond the control of the parties, technical or mechanical issues, accidents, illness, and if the Studio is unable to provide a reasonable alternative that is agreeable to the client, then a full refund will be issued. Studio shall have no further liability beyond the money paid by client, with respect to the agreement.
9. In the unlikely event that the Cali Foto Booth operator(s) are injured or become too ill to cover the event, the Studio will make every effort to secure a replacement photo booth vehicle or photo booth. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. In case of complete equipment failure that results in downtime of 15% or more of the operation time, the studio shall refund the appropriate amount to the client.
10. If the vehicles are placed outdoors and the event is rained out, a reasonable alternative shall be made available to the client. If the substitute service retails for less than the contracted service, a payment adjustment shall be made to the client for the difference.
11. The Studio takes the utmost care with respect to preserving and processing the photographs, including using professional grade equipment and professional grade backup equipment. However, in the event that photographs have been lost, stolen, or destroyed before they have been delivered to the Client, then the Studio is limited to the return of all payments received for the event package. The limit of liability for a partial loss of originals shall be a prorated amount of the images lost based on the percentage of total number of originals. Client(s) agree to limit the Studio's liability to the amount paid under this contract. After the successful delivery of the final product to clients, The Studio no longer takes responsibility over original or edited images. Studio will take utmost care of images, however makes no guarantees on preservation after image delivery. Studio encourages clients to back up deliverables on their own.
12. The Studio has the right to terminate services due to abuse of studio staff or equipment. In the event that our operators feel a threat to their well being, guest well being or the well being of studio equipment at the event, studio reserves the right to terminate services without any refund of fees. Photo booth attendants reserve the right to politely cut off individual guests requesting an excessive amount of photos at other guest's expense.
13. The client shall be liable for any damage done to the vehicles during the course of event, while the vehicle or the photo booth is on event premises.
14. With reprint on demand packages, the prints can only be reprinted after the last session. The operator will do their best to estimate the number of prints the guests would like, and reprint at guest request after the photos are taken.

15. Client agrees to provide a meal and refreshments for each operator in attendance, during appropriate meal times.

16. If you would like to personally thank our staff with a tip, please do so directly at the event.

17. A non-refundable retainer of 50% of the cost of the package is due at the signing of this agreement to hold your date. Any balance must be paid 30 days prior to the event in order for the studio to render services, unless other arrangements are made in writing.

I understand that Mirror X is an open photo booth setup, different from a traditional photo booth. I have familiarized myself with its features and what I am contracting for. Any questions should be directed to a Cali Foto Booth representative prior to signing the contract.

I / we confirm that I / we have read the herein agreement prior to its execution and I / we are fully familiar with the contents thereof. This agreement shall be binding upon us and our heirs, legal representatives and assigns.
